Pledge of Allegiance: Chairman Harter led the group in the Pledge of Allegiance.

Approval of June 7, 2023 Minutes: Supervisor James Heckman made a motion to approve the June minutes as presented; motion second by Supervisor Harter. Motion passed.

- Chris Harter, President of Walker Township Fire Company, presented the Board with the Fire Company's 2nd Quarter Financials.

Agenda Items: There were no Agenda Items.

ZONING:

- Zoning Officer Lesniak reported there were 14 Zoning Permits and 2 Driveway Permits issued in June, 2023. He continues to work on active complaints for Hoy Rd and Lisk Street.
- The John & Elsie Glick Minor Land Development – CCPCDO #66-23 was presented. After review by the Planning Commission and the Board of Supervisors the plan was denied. The proposed commercial use is not permitted in that Zoning District. The Sewage Module previously approved will not be submitted to DEP at this time.

ROADMASTER:

- The Minor issues resulting from the 2023 Road Project for Benner Rd (2023 Road Project) have not been completed yet.
- Supervisor Heckman made a motion to replace the Fire Truck sign at Cemetery Lane; motion second by Supervisor Harter. Motion passed.
- A request for more sand for the volleyball court was received.

- Supervisor Harter made a motion to appoint Alan Zimmerman to the Planning Commission Board; motion second by James Heckman. Motion passed.
- A date to hold a special meeting to discuss the Walker Township Water Association's hydrant billing was tabled until the August meeting.
- The balance of the American Rescue Fund disbursement was discussed but no action was taken.

Supervisor Heckman made a motion to approve the June 2023 General Fund Paid Bills in the amount of \$38,883.17 and June Treasurers Report; motion second by Supervisor Harter. Motion passed.
