**Call to Order:** Deb Zimmerman called the January 19, 2021 meeting of the Walker Township Parks & Rec Board to order at 6:00pm in the Walker Township Municipal Building. Deb led the group in the Pledge of Allegiance. Patty Correll motioned to approve the minutes from the November 17, 2020 Meeting as presented; motion second by Jan McDowell and approved by all members present. No meeting was held in December.

**Guests:** Wyatt Harter introduced himself as the new Vice-President of the Nittany Valley Little League and reported the new Board has started planning for the 2021 season. He said that the outfield fence on field 1 is badly rusted and needs replaced and some ground work is needed at the T-ball field. - Three benches were purchased and installation will be scheduled.
- The Little Free Library is undergoing repairs and painting.

- Cheryl Vonada chose not to be reappointed to another term on the Board. The vacancy will be advertised on the website.
- No action was needed for the Subdivision of Lands of John and Elsie Glick CCPCDO#149-20.
