Deb Zimmerman motioned to reimburse the League for the previously committed amount of \$4,500.00; motion second by Pam Rogers and approved by all members present. The payment will be made from the Fee-in-Lieu account.
- There was no further discussion regarding needed repairs to the outfield on field 2.
- Deb is working on getting estimates for resurfacing the basketball and tennis courts and possible pickleball court.
- There were no further repairs made to the fence at the basketball courts.
- Deb is waiting for a response from Playworld regarding the damaged playground equipment. The equipment has been temporarily repaired.
- Deb reported Walker Township has been approved to receive American Rescue Funding. She is reviewing the guidelines for distribution.
- The Board will investigate adding workout stations to the park.
- Leah Burd was approved to serve on the Board to fill the unexpired term of Donna Snyder.
- The Buddy Bench plaques have been received and will be installed. The two benches at the Scout project at the back of the park will be replaced.
- Patty completed the 2021 newsletter and they are ready to prepare for mailing.
- Plans for the Fall Festival are moving along. Vendor Registration forms are ready for distribution. Patty said she needs volunteers to help with the events.

**New Business:**

- Deb reported that the comment boxes are installed and they are being filled with stones and nasty notes. She also reported there was vandalism done to one of the restrooms.
- The Board noted the paid bills.
